

ORDINANCE NO. 16-1324

**AN ORDINANCE CHANGING THE NAME OF A PORTION OF PONTIAC DRIVE TO VANGUARD WAY**

---

**WHEREAS**, the Village of Cahokia, St. Clair County, Illinois, is a duly organized and existing municipality created in accordance with the laws of the State of Illinois;

**WHEREAS**, the Village of Cahokia is now operating under the provisions of the Illinois Municipal Code, as supplemented and amended, and as a home rule municipality pursuant to Article VII of the Illinois Constitution of 1970; and

**WHEREAS**, a request has been presented to the Village of Cahokia, Illinois to change the name of a portion of the street known as Pontiac Drive to Vanguard Way; and

**WHEREAS**, the Illinois Municipal Code, at 65 ILCS 5/11-80-19, authorizes the corporate authorities of the Village of Cahokia, Illinois to change the name of any street within its corporate boundaries;

**WHEREAS**, the Board of Trustees of the Village of Cahokia previously passed Ordinance No. 895, titled an Ordinance Changing a Portion of Sonny Drive in the Village of Cahokia, Illinois to Pontiac Dirve (sic); and

**WHEREAS**, the Village of Cahokia desires to amend Ordinance No. 895 to change the name of a portion of Pontiac Drive to Vanguard Way.

**NOW THEREFORE, LET BE IT ORDAINED BY THE PRESIDENT AND MEMBERS OF THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF CAHOKIA, ST. CLAIR COUNTY, STATE OF ILLINOIS, as follows:**

1. The preceding paragraphs are incorporated herein by reference.

2. That the portion of Pontiac Drive commencing at the location where the south corner of St. Clair County Parcel No. 06-12.0-100-018 meets the west corner of St. Clair County Parcel No. 06-12.0-100-019, and ending at the point where Pontiac Lane terminates at Sonny Lane, is hereby renamed Vanguard Way.

3. The Village Clerk is hereby directed to promptly provide the statutory notice required by 65 ILCS 5/11-80-19 to the election authorities having jurisdiction in this area and to the post office branch serving this area.

4. This change in street name shall be effective thirty (30) days after the Village Clerk has provided the notices described in paragraph 3 above.

5. This Ordinance hereby amends Ordinance No. 895 in the manner described above and repeals all other ordinances, or parts thereof, in conflict with the provisions of this Ordinance.

Passed this 9 day of February, 2016, pursuant to a roll call vote by the President and Village Board of Trustees and deposited with the Office of the Clerk of said Village on said date.


