

ORDINANCE NO. -19-1366

**AN ORDINANCE INCREASING THE SALARY OF
THE CHIEF OF POLICE, THE CAPTAIN, THE LIEUTENANTS AND
THE ADMINISTRATIVE ASSISTANTS OF THE
VILLAGE OF CAHOKIA POLICE DEPARTMENT**

WHEREAS, the Chief, Captain, the Lieutenants and the Administrative Assistants employed by the Police Department of the Village of Cahokia have not received a wage increase for a number of years; and

WHEREAS, the Mayor and Village Trustees desire to bring their wages up to a fair and equitable rate of compensation.

BE IT ORDAINED BY THE MAYOR AND THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF CAHOKIA, ILLINOIS AS FOLLOWS:

Section I – New Hourly Wages

As of the date of the passage of this Ordinance, the new hourly wages of The Chief, the Captain, the Lieutenants and the Administrative Assistants are as follows:

Chief David Landmann:	\$57.11
Captain Dennis Plew:	\$49.99
Lt. Gary Brewer:	\$45.75
Lt. Benjamin Callahan:	\$43.99
Lt. Damon Pipkens:	\$44.82
Administrative Assistant Tanya Mobbs:	\$24.62
Administrative Assistant/Evidence Technician:	\$23.23

Section II – Repudiation of Management Personnel Agreement


The parties to this Ordinance specifically repudiate, disclaim and acknowledge of no force and effect that certain purported agreement that is the subject of a lawsuit bearing cause number 2015-CH-139 pending in St. Clair County Circuit Court, State of Illinois and referred to as the Management Personnel Agreement.
