

VILLAGE OF CAHOKIA, ILLINOIS

ORDINANCE NO. 20-1373

AN ORDINANCE ANNEXING CLEOPHUS RANDY PEARCE PARCELS 07-07.0-200-073  
AND 07-07.0.200-074 INTO THE VILLAGE OF CAHOKIA, ST. CLAIR COUNTY,  
ILLINOIS

WHEREAS, a written Petition, signed by the legal owner of record of all of the land within the territory hereinafter described (Subject Territory), has been filed with the Village Clerk of the Village of Cahokia, St. Clair County, Illinois, requesting that the Subject Territory be annexed into the Village of Cahokia; and,

WHEREAS, at least fifty-one percent (51%) of the electors residing on or in the Subject Territory have executed a written petition pursuant to 765 ILCS 7-1-8 requesting that the Subject Territory be annexed into the Village of Cahokia, St. Clair County, Illinois; and,

WHEREAS, the Subject Territory is not within the corporate limits of any municipality but is contiguous to the Village of Cahokia; and

WHEREAS, legal notices regarding the intention of the Village of Cahokia to annex the Subject Territory have been sent to all public bodies required to receive such notice by State statute; and,

WHEREAS, copies of such notices required to be recorded, if any, have been recorded in the Office of the Recorder of St. Clair County; and,

WHEREAS, all petitions, documents, and other necessary requirements are in full compliance with the Laws of the State of Illinois, specifically including but not limited to the provisions of 65 ILCS 5/7-1-8; and,

WHEREAS, it is in the best interest of the Village of Cahokia that the Subject Territory be annexed thereto.

NOW THEREFORE, be it ordained by the Mayor and the Trustees of the Village of Cahokia, St. Clair County, Illinois, as follows:

Section 1: That the following described territory, being indicated on an accurate map of the annexed territory, a copy of which said map is herewith attached and incorporated by reference as part of this Ordinance as Exhibit 3, is hereby annexed into the Village of Cahokia, St. Clair County, Illinois, to-wit:
