

ORDINANCE NO. 20-1377

AN ORDINANCE ESTABLISHING NEW WATER RATES FOR THE VILLAGE OF CAHOKIA, ILLINOIS N/K/A BOROUGH OF CAHOKIA

WHEREAS, the Village of Cahokia n/k/a Borough of Cahokia operates a system that distributes water to its residents; and,

WHEREAS, it is time to increase the water rates charged for said water usage.

NOW THEREFORE BE IT ORDAINED BY THE MAYOR AND THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF CAHOKIA, ST. CLAIR COUNTY, ILLINOIS THAT:

Section 1. That the following water rates are established for the Village of Cahokia n/k/a Borough of Cahokia:

WATER RATES. There shall be established the following rates and charges for the use of water and sewer system of the Village, based upon the amount of water consumed as follows:

A. Proposed Rate Structure (Less Than 100,000 Gallons Per Month):

Water Usage	Monthly Rate
0 to 2,000 Gallons	\$23.90 (minimum charge)
Next 3,000 Gallons (2,001 to 5,000)	\$0.697 Per 100 Gallons
Next 5,000 Gallons (5,001 to 10,000)	\$0.668 Per 100 Gallons
Next 10,000 Gallons (10,001 to 20,000)	\$0.636 Per 100 Gallons
Next 20,000 Gallons (20,001 to 40,000)	\$0.568 Per 100 Gallons
Next 60,000 Gallons (40,001 to 100,000)	\$0.492 Per 100 Gallons)

B. Proposed Rate Structure (100,000 Gallons or More Per Month):

Water Usage	Monthly Rate
First 100,000 Gallons	\$550.22 (minimum charge)

Over 100,000 Gallons

\$4.51 Per 1,000 Gallons


Section 2. All conflicting ordinances or pertinent portions thereof, in force at the time this Ordinance shall take effect are hereby amended.
